SUMMARY ANNUAL REPORT FOR MCASF LOCAL 725 HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the MCASF Local 725 Health and Welfare Trust Fund (Employer Identification Number 59-6150964, Plan Number 501) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Board of Trustees MCASF Local 725 Health and Welfare Trust Fund has committed itself to pay certain medical, prescription drug, temporary disability, and life insurance claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Amalgamated Life Insurance Company, Gerber Life Insurance Company, and Florida Combined Life Insurance Company, Inc. to pay certain stop loss, specific transplant critical care coverage, and dental contract claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2020 were \$1,340,236.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$21,472,224 as of the end of plan year, compared to \$18,885,410 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$2,586,814. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$13,594,681 including employer contributions of \$11,820,286, employee contributions of \$84,540, gains/(losses) of \$180,956 from the sale of assets, and earnings from investments of \$1,508,899. Plan expenses were \$11,007,867. These expenses included \$1,275,066 in administrative expenses, \$80,595 in benefits paid to participants and beneficiaries, \$1,302,268 paid to insurance carriers for the provision of benefits, and \$8,349,938 in claims paid.

Paperwork Reduction Act Statement
